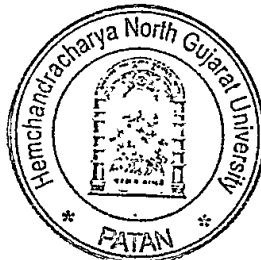

Eligibility (A or B)

A)

- i. A Master's degree with 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in a concerned/relevant/allied subject from an Indian University or an equivalent degree from an accredited foreign university
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET or who are or have been awarded a Ph.D degree in accordance with the University Grants Commission (Minimum standards and procedure for award of M.Phil./ Ph.D Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET.

Provided the candidates registered for the Ph.D programme prior to July 11,2009 shall be governed by the provisions of the then existing Ordinances/Bye laws/ Regulations of the institution awarding the degree and such Ph.D candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in universities/colleges/institutions subject to the fulfillment of the following conditions.

- a) The Ph. D. Degree of the Candidate awarded in regular mode only.
- b) The Ph. D. Thesis has been evaluated by at least two external examiners.
- c) An open Ph.D. viva voce of the candidate has been conducted.
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal.
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the university concern.

Note :- NET/SLET/SET shall not be required for such Master's Degree programs in disciplines for which NET/SLET/SET accredited test is not conducted.

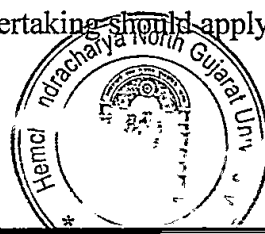

This appointment is to be made **purely on contractual basis** for the fixed tenure of **11 months period extendable up to 03 (Three) years with an appropriate gap as per HNGU Contractual Employees Policy-2025.** The University reserves the right to discontinue this appointment at any point of time due to non-availability of sufficient workload in the concerned subject/department and or appointment of the permanent teacher in the concerned Department of the Faculty/ College/ Institute of the University.
5. Candidates are advised to go through the minimum eligibility criteria carefully and make sure they possess the same before filling up the online application form. No query in this regard will be entertained.
6. The selected candidates would be appointed on the fixed monthly salary/emoluments and other benefits mentioned in HNGU Contractual Employees Policy - 2025.
7. The qualifications and other conditions prescribed in the present advertisement are subject to the norms stipulated by the University from time to time.
8. Experience and Qualifications will be reckoned as on the last date fixed for the submission of online applications. No updating of Educational Qualifications and Experience will be entertained after the last date fixed for the submission of online applications.

14. Candidates already employed in Govt./Semi. Govt./Public Sector undertaking should apply through proper channel else produce No Objection Certificate whenever required.



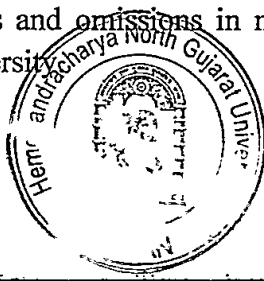

15. The required qualifications/experience/age shall be considered as on last date of online application submission.
16. Applicants are advised to submit the documents related to their change of name (if applicable) (i.e. Marriage Certificate, Gazette for Name Change, Aadhaar Card).
17. Applicants are advised to submit the applications to the University well in advance without waiting for the last date to avoid postal delay or any delay due to other unforeseen events or circumstances. The University shall not be responsible for any postal delay at any stage.
18. Applicants must produce original testimonials, certificates/educational qualifications and other documents at the time of interview.
19. Canvassing in any form on behalf of or by any candidate will disqualify him / her from being considered.
20. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issuance of appointment letter, the University reserves the right to modify/withdraw/cancel any communication made to the candidates.
21. The University shall verify the antecedents and documents submitted by candidates at any time, at the time of appointment or during the tenure of service. In case it is detected that the documents submitted by the candidates are fake or the candidates have undesirable clandestine antecedents/background and have suppressed the said information, his/her services shall be liable to be terminated.
22. The candidate should have obtained his or her degree of Graduation, Post-Graduation, Ph.D. or equivalent degree from a recognized university/institution as approved and recognized by the UGC/ACTE/PCI etc. as per the regulations of such other statutory bodies, councils etc. and subsequent amendments, if any shall be applicable as amended from time to time.
23. Candidates, who have obtained degrees or diplomas or certificates for various courses from any Institution declared fake/derecognized by the statutory bodies, shall not be eligible for being considered for recruitment to the posts advertised.
24. The character of a person to the service must be such as to render him/her suitable in all respect for appointment to the service.
