- 3.4.1 There shall be age relaxation for 5 years for candidates serving in Government Organizations working in post which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of duties of the advertised post.
- 3.4.2 The upper age limit in respect of SC, ST, OBC (NCL) and PwBD and other special categories of persons shall be relaxable in accordance with the orders issued by the Central Government from time to time in this regard.
- 3.4.3 The age relaxation for SC/ST/OBC(NCL) candidate is applicable for the post reserved for them. However relaxation in age limit for PwBD candidate will be applicable irrespective of the fact whether the post is reserved for them or not, provided the post is identified suitable for them.

**NOTE (Age calculation) :** The crucial date for determining the age limit shall be 31/03/2026.

**4. PLACE OF POSTING:**

The person selected may be posted **anywhere in India and outside India** in the interest of the Organization.

**5. HOW TO APPLY:**

**Before applying, candidates are advised to go through this advertisement carefully in detail to determine their eligibility as per laid down criteria for the post.**

The admission at any stage of the recruitment will be purely provisional, subject to satisfying the prescribed eligibility conditions.

Candidates are requested to apply only by ONLINE at <https://recruitment.nic.in> between **27/03/2026 to 24/04/2026 (5:30 p.m)**. No other means/mode of application will be accepted.

Candidates are required to have valid **E-mail Id** and active **Mobile Number**. The procedure/steps for filling up of applications online is briefed as under.

The complete Application can be submitted in **following 4 steps:**

**STEP 2:** Fill online Application Form & uploading documents.

**STEP 3:** Payment of application fee online (*if applicable, see section 5.2 for details*)

The application shall be treated as complete only if all the four mandatory steps (Step 1, Step2, Step 3 (if applicable) and Step 4) are completed successfully. **In case, candidate is not able to submit fee by closing date and time, or the application is otherwise incomplete, his/her candidature will summarily be rejected and no further query or complaint will be entertained in this regard.**

Applicant can view the Application details from the “**Already Registered Candidate**” option available on the home page by logging with correct login credentials i.e. Application number and Password created. Applicant is required to make sure that ‘Steps for filling up Application Form are completed in all respect to download the Confirmation Page’ otherwise application will be treated as incomplete and summarily rejected **and no further query or complaint will be entertained in this regard.**

Candidates who are applying for more than one discipline need to pay Rs. 800/- for every discipline.

Fee through any other mode like Cash, Demand Draft, Pay Order, Cheque or Challan will **not** be accepted.

**Note:** Application fee once paid will not be refunded.

## 6. SELECTION PROCESS:

6.1 Only those candidates fulfilling the eligibility criteria mentioned at point 3 and have registered their application on the portal of NIC shall be considered for further selection process in NIC.

6.2 Eligible candidates will be shortlisted for interview/interaction, on the basis of GATE Score in the ratio of 1:5 subject to their availability in order of discipline-wise and category-wise merit list. If there are more than one candidate with the same GATE Score (while shortlisting for interaction/interview), then all the candidates with the same Score will be shortlisted and called for interaction/interview irrespective of the ratio stated above.

6.3 Equal weightage will be given to GATE 2024, GATE 2025 and GATE 2026 Scores.

6.4 Shortlisted candidates can download their call letters for the Personal Interaction/Interview from the link available on the website (www.recruitment.nic.in). Candidates will have to regularly visit NIC recruitment website for link or any other information.

6.5 Mere fulfilling of requirements as laid down in the advertisement does not qualify a candidate to be called for personal interaction/interview.

6.6 Document verification will be conducted before Interaction/Interview. In case a candidate does not appear for document Verification along with original documents, he/she shall not be eligible for personal interaction/interview/provisional selection, and his/her candidature shall be rejected.

6.7 Upon completion of document Verification, candidates found eligible only shall be allowed to appear for interaction/interview, subject to fulfillment of all other eligibility criteria prescribed for the post.

6.8 Candidates will be assessed in the interaction/interview based on the following attributes (Max marks 50):

- a) Technical (Academic) knowledge
- b) Presentation/Communication Skill/Comprehension
- c) Academic performance (0.05 mark for each percentage in the degree of Essential qualification)  
In case of CGPA, if the university does not provide a formula, the candidate must provide a certificate from the Registrar to that effect.

6.9 Only those candidates securing minimum qualifying marks of 50% (for Unreserved category) and 40% (for EWS/OBC/SC/ST/PwBD category) in the Personal Interaction/Interview will be considered for preparation of the final merit list. Candidates who do not qualify the interaction/interview will not be considered for final selection irrespective of their GATE score.

6.10 The final selection of the candidates will be purely on the basis of category-wise and discipline-wise merit of aggregate of 60% weightage of gate score and 40% weightage of marks in personal interview/interaction.

#### 6.11 Resolution of TIE cases:

In case of a tie in the total marks (GATE Score weightage + Personal Interaction/Interview weightage) scored between two or more candidates, following criteria will be adopted in order of sequence for deciding position in merit list:

**First** - The candidate with higher scores in the GATE paper shall be ranked higher in the merit list.

**Second** – If two candidates have equal scores in the GATE paper, then candidate with more marks in the Technical (Academic) knowledge section of the interaction/interview, would be ranked higher.

**Third** – If there is still a tie, then candidate older in age shall be ranked higher in the merit list.

### 7. VERIFICATION OF DOCUMENTS:

Verification of requisite documents will be conducted before the interaction/interview. Candidates will be interviewed only after production of **original documents** for verification. If the identity of the candidate is in doubt or he/she cannot produce the requisite documents or there is mismatch of information in the documents, his/her candidature will be rejected. No additional time will be given to produce original documents.

The following original documents will be verified at the time of interaction/interview. Non-production of original documents will debar the candidate from appearing for the interaction/interview:

## **8 Personal Interaction/Interview:**

Details of date and venue of the interaction/interview of the shortlisted candidates will be provided in the Call letter to be downloaded from the link provided on the NIC website (<https://recruitment.nic.in/>).

Interactions/Interviews shall be conducted at Delhi or at any other location /mode approved by competent authority.

**No request for postponement or change in location shall be allowed/entertained.  
No TA/DA shall be paid for attending the interaction/interview.**

## **9 ACTION AGAINST MISCONDUCT.**

Candidates are advised in their own interest that they should not furnish any particulars that are false, tampered or, fabricated and should not suppress any material information. A candidate is liable to be prosecuted for misconduct if during or at any stage of recruitment, he/she has been found guilty of;

- Impersonating or procuring impersonation by any person; or
- Resorting to any irregular means in connection with his/her candidature during Selection process; or
- Using unfair means or obtaining support for his/her candidature by any means; or
- Canvassing in any form/using undue influence for his/her candidature by any means; or
- Submitting false certificates/documents/information or concealment/suppression of factual information at any stage;
- Giving wrong information regarding his/her category (SC/ST/OBC(NCL)/EWS/PwBD) while applying for the post or thereafter;

The candidature of such candidates will be summarily rejected/cancelled at any stage of recruitment process / will be terminated from service (if already appointed), in addition to rendering himself/herself liable to criminal prosecution and may also be liable to be debarred either permanently or for a specified period from any recruitment to be conducted by NIC.

## **10 IMPORTANT INFORMATION**

### **10.1 CITIZENSHIP:**

A Candidate must be either: (a) a citizen of India, or (b) a subject of Nepal, or (c) a subject of Bhutan, or (d) a Tibetan refugee who came over to India before 1st January, 1962 with the intention of permanently settling in India, or (e) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka or

Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India. Provided that a candidate belonging to categories (b), (c), (d) and (e) above shall be a person in whose favor a certificate of eligibility has been issued by the Government of India.

#### 10.2 **CRUCIAL DATE FOR AGE, QUALIFICATION AND EXPERIENCE:**

The Crucial date for calculating the age as well as completion of eligibility conditions with regard to essential qualifications, category, age relaxation etc. shall be the cut-off date i.e. **31/03/2026** which will remain unchanged even in case of extension of the closing date for submission of applications.

#### 10.3 **CORRESPONDENCE**

All correspondences with the candidate in connection with the recruitment will be made by NIC through e-mails/SMS on the registered e-mail ID and Mobile number submitted by the candidate. The candidates must, therefore indicate his/her primary email ID and active primary mobile number in the online application form on which the communication regarding this recruitment process would reach to the applicant. Intimation regarding joining/appointment of selected candidates will also be made through the registered Email ID and Mobile number by NIC. Hence the candidate must regularly check their emails/SMS.

#### 10.4 **APPLICATION FEE PAYMENT & ELIGIBILITY**

NIC will not be responsible in case of incomplete transactions during the online payment process. It is the sole responsibility of the candidate to ensure that the correct payment of application fee has been made successfully. Application fee once paid is non-refundable.

Applicants, in their own interest, should check their eligibility for the post before remitting the application fee. Only qualifications mentioned against post shall be considered for determining the eligibility.

### 11 **IMPORTANT INSTRUCTIONS**

- 11.1 Applications which are not in conformity with the requirement indicated in the advertisement, are liable to be rejected.
- 11.2 Candidates at the time of interaction/interview shall bring the downloaded Interview Call Letter, Originals documents as stated at point 7 alongwith one recent passport size colour photograph, failing which they will not be allowed to appear in the interaction/interview.
- 11.3 Final Selection of candidates for appointment to the above advertised post will be based on meeting the prescribed eligibility criteria, GATE Score and the performance in the interaction/interview.

- 11.4 If at any point of time it is found that the information furnished by the candidate was incorrect in any respect or forged /fabricated documents were presented by any candidate, his/her candidature will be cancelled and in case the candidate has already joined the post, his services shall be summarily terminated.
- 11.4.1 The candidates should upload only relevant documents. It should be kept in view that uploading of irrelevant documents may lead to disqualification of the candidature/rejection of the application Form. Non-submission of the documents as stated at Checklist 5.1 may lead to cancellation/rejection of the Application Form.
- 11.4.2 Candidates shall have eligibility qualification complete in all respects by cut-off date.
